Indian Statistical Institute, Delhi Centre invites applications for engaging one Consultant (Electrical Engineer) from retired persons from Central Government/Autonomous organisations of Government of India on contract basis for a period of one year extendable based on need and performance. The consolidated remuneration inclusive of all allowances shall not exceed the amount arrived at by deducting the basic pension from the last pay drawn (Basic Pay) drawn at the time of retirement. There will be no annual increment/percentage increase during the contract period. Age limit should be below 62 years as on June 30, 2024. Interested candidates may appear for a Walk-in-Interview on August 20, 2024 between 11.00 A.M. to 1.00 P.M. at the above mentioned address. The reporting time is between 9.30 A.M. to 10.30 A.M. Candidates arriving after conclusion of the walk-in-interview timings will not be allowed. The essential educational qualifications, experience and other details for the post of Consultant (Electrical Engineer) are as follows: -

- 1. Age: Should be below 62 years as on June 30, 2024.
- 2. Qualifications: A good Bachelors degree in Electrical Engineering or equivalent in Electrical Engineering from a recognized university and/or Institute in India through regular mode.
- 3. Experience: Minimum of 15 years in Central Government/Autonomous organizations of Government of India and with experience in preparing designs, estimates, execution and inspection of works etc.
- **4. Remuneration**: The consolidated remuneration inclusive of all allowances shall not exceed the amount arrived at by deducting the basic pension from the Last pay(Basic Pay) drawn at the time of retirement. Example: An employee retired in the pay Level 13 and the pay at the time of retirement was Rs.1,55,900. Thus, the basic pension will

be Rs, 77,950. If the employee is appointed on contract basis, including as Consultant, the remuneration shall be fixed at Rs. 77,950 (1,55,900-77950). The basic pension to be deducted from the last pay shall be the pension as fixed at the time of retirement and as such, if the employee has availed of the commuted value of pension, the commuted portion of pension shall also be included in the portion of pension to be deducted. Thus in the above example, if 40% of pension was commuted, the commuted portion shall be Rs. 31,180 (40% of 77,950) and the pension actually drawn shall be Rs. 46,770. However, the amount of pension to be deducted from the last salary shall be Rs. 77,950. Accordingly, the person so engaged as Consultant(Electrical Engineer) at ISI, Delhi Centre the consolidated remuneration shall be fixed as per the above example. There will be no annual increment/percentage increase during the contract period. The Consolidated remuneration will remain constant during the contract period and no DA shall be paid.

- **5. Tax Deduction at Source [TDS]:** TDS as admissible shall be deducted from the monthly remuneration of Consultant(Electrical Engineer). A TDS certificate shall be issued by the concerned DDO on demand.
- **6. Period of engagement**: The Consultant(Electrical Engineer) will be engaged for a period of one year from the date of joining. The engagement can be extended or curtailed depending on the performance of Consultant(Electrical Engineer) or the need of the Institute. He/She will be required to attend office on all working days during office hours of the Centre and should be available for advice/consultation if and when required even on holidays.
- 7. **Temporary Engagement:** The engagement will be purely on temporary basis and it will confer no right as Consultant(Electrical Engineer) for regularization/permanent appointment in any case.
- **8. Supervision**: The Consultant(Electrical Engineer) will work under the direct guidance and supervision of Deputy Chief Executive(Admn) 'A' of the Institute.

#### The General Terms & Conditions of Engagement are as listed below:-

- 1. No leave, except 8 days of casual leave in a calendar year.
- 2. TA/DA: TA/DA is allowed for travel in the country in connection with official work as per normal rules applicable to any serving officer of the rank of Senior Administrative Officer of the Institute.


- 3. The Consultant (Electrical Engineer) will be based in Delhi.
- 4. The Consultant (Electrical Engineer) is expected to perform the following duties/functions.
  - (a) He/she will be overall In-Charge of Electrical Maintenance Unit.
  - (b) He/she will be responsible for preparing of tender documents, scrutiny etc.
  - (c) Supervision of ongoing electrical works.
  - (d) Scrutiny of bills.
  - (e) Preparation of duty charts of workers deployed through outsourced agency.
  - (f) Coordinate with various agencies/departments/units for smooth and efficient functioning of Electrical Maintenance Unit.
  - (g) Ensure Govt. regulations and compliances are strictly complied and adhered to.
- 5. Further the Consultant (Electrical Engineer) should be in sound health (both physically and mentally), should not be accused in any pending inquiry and should be of impeccable integrity. A certificate from the appropriate authority will be required to be furnished.
