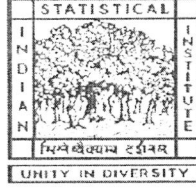

4. विवरण फार्म(quotation) सिग्नेचर किये बगैर और स्टाम्प लगाये बगैर मिला तो सीधे सीधे निरस्त किया जाएगा .
5. कोटेशन में दिए गए आपके कूल राशि (Biling) पर टैक्सेज एप्लीकेबल रहेंगे.

11. The intending Tenderers shall submit definite proof of registration certificates and list of works(same above only) completed along-with copy of certificates/ testimonials of their satisfactory completion from the department concerned officer -in-charge of the work, while submitting the tender.
12. The chemical intended to be used shall be enlisted by World Health Organization [WHO] in its specifications for use in public health programme.
13. Material shall be approved by the concerned government authority for National Malaria Control Programme [NMCP].
14. Material shall be odorless and stainless i.e. it should not leave any stains on the outer peripheral wall of residential and public buildings.
15. The chemical intended to be used for fogging in no case shall be hazardous to human being and shall be environment friendly.
16. The chemical intended to be used shall be diluted with Diesel only as per the manufacturer's specification & recommendations.
17. The formulation comprising of pyrethrum 2% and Diesel (0.1% strength) with 2% @ 15 to 30 ml per 1000 CFT shall be used as per manufacturers recommendations.
18. The material (Chemical) shall be approved brand i.e. Lakshaya (Deltamethrin 1.25% ulv, Smoker (Deltamethrin 1.25% ulv etc. OR its equivalent.
19. One round of fogging operation shall be take ata atimes of month.
20. Fogging operation shall be carried out after 5.30 pm and not later than 7 pm [i.e. between 5.30 pm to 7 pm], because this is the period when mosquitoes attack and are active.
21. Chemical intended to be used for fogging operation shall produce fumes, which should diminish within 2 minutes of fogging operation.
22. The sample shall be got approved first and then the supply shall be made in bulk quantity
23. The chemical intended to be used shall produce fog having particle size not more than 5 Micron
24. The operation shall be carried out with minimum 2 fogging machines and there shall be 1 standby machine.

25. The fogging operation shall strictly be carried out under supervision of Civil Supervisors.
26. All safety precaution shall be taken as per manufacturer's recommendations:
27. All the workers shall be provided with PPE's as per manufacturer's recommendations on safe health practicing.
28. Wear full protective clothing while mixing and spraying
29. Do not smoke, drink, eat & chew anything while spraying.
30. Covers all food stuffs before application.
31. Wash hands and exposed skin after use.
