**APPEAL U/S 19 OF THE RIGHT TO
INFORMATION ACT, 2005**

MOST RESPECTFULLY SHOWETH AS UNDER:-

BRIEF FACTS OF THE CASE:-

1. That the appellant had preferred an RTI application dt. 23/2/13 under section 5 of the RTI Act in following information was sought from CPIO, ISI, the Defendant.

All information required with the Construction of the new mess building and Allied works t ISI Delhi Centre.

- How many drawings have been issued to A2Z Constructions?
- How many drawings (mentioned above) belong to main mess building?
- Who has signed the drawings on behalf of ISI?
- Letter No. and Date under which drawings were issued to M/S A2Z Constructions



- Were these drawings issued to all contractors who applied for issue of tenders?
 - How many letters have been written by Mr. T Narayanan Swami as in charge of work to A2Z Constructions regarding stoppage of work / Start of work / removal of defects / dismantling of any part of work.
 - No. and Date of letter asking M/S A2Z Constructions to submit cube test report conducted by the Engineer in charge
 - General Information:
 - Procedure adopted for granting advance payment against material supplied
 - Name of the contractor to whom advances have been issued during the period 1-4-2008 to 31-3-2009 and 1-4-2009 to 31-3-2010
2. That vide their letter no. CAP/21-A/102/2012-13/865 dt. 12.3.2013 the Ld. CPIO, ISI denied the disclosure of information sought arbitrarily.
3. That being aggrieved from the above action of the Ld. CPIO, ISI, the appellant has preferred the present appeal on following beside other grounds.

GROUND OF APPEAL

1. The defendant has erred in law and on facts in denying the information sought by the appellant.
2. The defendant has erred in law and on facts in not disclosing the information sought on arbitrary grounds taking the shield of section 8(1)h of the RTI Act. It is submitted that the information sought does not impede any investigation in any manner.
3. The defendant has erred in law and on facts as they deliberately failed to supply the information sought and the documents relating thereto.

For the foregoing clauses, it is most respectfully prayed that your good self be pleased to direct the defendant to: -

- (a) Supply to the appellant accurate / complete information in compliance of the section 5 of the Act;
- (b) Supply to the appellant copies of the documents and proceedings of the case;
- (c) Any other relief(s), which this Hon'ble Forum may think fit & proper in the circumstances of the case.
