- b. What is the type of each rental accommodation viz: residential, commercial etc?
- c. What is the area (in sq. feet) and location of each of the rental premise?
- d. What is the rent per month of each rental premise?

- f. Whether finance approval was taken by the Head of the Centre before taking any final decision on rentals? If yes, from whom the approval was taken? Provide the supporting documents.
- g. Whether the rent agreed upon was as per the Government norms? If yes, provide the supporting documents.
