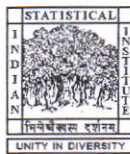

With reference to your RTI application dated 05.12.2013, received by the CPIO on 09.12.2013, the information, as sought for, are furnished below:-



(3)	(a) 1st and 2nd RA bill were against material What was the material supplied by the contractor against which secured advance was granted. (b) Payments were approved by Sh. R.B. Bapat, A.G. Bhatt, S.P. Das. Did they approve payment in good faith? If yes, what was the reason for making payment in good faith?	(a) Extract of MB 30 is enclosed. (b) Queries do not relate to any existing document. It does not seem to continue "information" as per RTI Act.
(4)	Under which clause of agreement payment can be made in good faith?	No mention of "good faith" in any clause.
(5)	On whose recommendation bills were approved by Shri R.B. Bapat, A.G. Bhatt, S.P. Das.	Based on the recommendation of Engineer (Civil), calculation checked by Accounts Section and duly approved by DCE, it was finally approved by Head, Delhi Centre.
(6)	How many secured advances can be given to a contractor and on what basis.	Does not relate to any existing document.
(7)	Who was competent to sign structural stability certificate on the drawings to be issued to M/s A2Z Constructions.	Structural Stability Certificate : Non existent

(8)	Number and date of letter issued to M/s A2Z Construction informing him about change of Engineer (Civil) {Appointment of Consultant Engineer need not be referred}.	Non-existent.
(9)	The work of contractor was stopped by Shri S.P. Das on 05.09.2011, was any letter written to contractor to attend site and have inventory of material lying at site.	No
(10)	Has anybody ever evaluated the value of material of contractor (M/s A2Z Construction) lying at site.	No.
(11)	Has any recorded the quantity of material lying at site. If yes, kindly supply copy of same.	A copy of the letter dated 18.10.2011 is enclosed.
