With reference to your RTI application dated 17.12.2013, received by the CPIO on 19.12.2013, the information, as sought for, are furnished below:-



(2)	Another work order for Rs. 16.88 lakhs was issued by Sh. R.B. Bapat, Head Delhi Centre, vide letter dated 9.03.2011 and the same was also to be executed upto 31.03.2011. How much work was completed by 31.03.2011?	-do-
(3)	Another work order for Rs. 79.80 lakh was issued by Sh. S.P. Das Head Delhi Centre vide letter dated 28.04.11. Did contractor complete the work of Rs. 20 lakhs and Rs. 16.88 lakhs before issue of work order for Rs. 79.80 lakhs.	-do-
(4)	What was role of DCE Sh. S.S. Sethi in making payment to contractor?	All the bills are routed through the DCE.
(5)	How many departments are under charge of DCE?	Housekeeping, Accounts, Estate, Civil Electrical till 08.04.2013.
(6)	Was the work being executed between 1.4.11 to 27.4.11 or was it stopped?	The work was suspended on 05.09.2011.
(7)	What were the hindrances recorded during this period.	No such records are held / maintained.
(8)	Did Sh. R.B. Bapat made visit to site before making payments?	The payment is made on the basis of checking and recommendations of the concerned officers.

(9)	Did Sh. A.G. Bhatt made visit to site before making payments?	-do-
(10)	Did Sh. S.P. Das made visit to site before making payments?	-do-
(11)	How much amount of performance guarantee (PG) money has been released by the Institute to the contractor. Kindly supply date and number of FD receipt released.	Not yet released.
