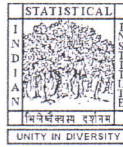


With reference to your RTI Application, dated 04.02.2013, received by the CPIO on 06.02.2013, para wise information against the queries are furnished below:
