Terms and Conditions: -

- 1. The bidder should fulfil the criteria of satisfactory execution of at least 1 similar type of work and should submit the work experience certificate / Work Order in support of the same from the respective department.
- 2. The bidders should submit valid PAN No. &GST No.
- 3. The rates for the above work shall be valid for one year and during this period the work will be carried out as per the need basis or direction of the institute authorities.
- 4. Before submission of bids, the bidders are advised to inspect the site to fully acquaint themselves.
- 5. Payments shall be made based on the satisfactory actual work done and based on the actual measurement, after deduction of 5% of the contract value, which shall be retained by the Institute as security to cover the defects liability for a period of six months from the date of completion. During this period, if any defect is detected, the same shall be rectified immediately by the successful bidder. No extra payment will be made.
- 6. The works shall be carried out strictly as per the latest CPWD specification of work and works manual under the supervision of the Institute's Engineer.
- 7. ISI Delhi Centre reserves the right to reject any or all the bids or cancel the tender process at any stage without assigning any reason.
- 8. The guoted rates shall be inclusive of all taxes and charges as applicable.
- 9. The workers to be deployed under the scope of the contract shall be provided personel protective equipment's (PPEs) as required.
- 10. Any loss/ damage or theft caused to the public property/ ISI Delhi Centre / manpower engaged shall be the sole responsibility of the successful bidder.
- 11. The contractor shall be responsible for their good character; all damage done to the existing structure shall be made good by the contractor at his own cost.
- 12. ISI Delhi Centre shall not be responsible for any injury or loss of life i.r.o. of the workers of the successful bidder that may arise out of and in the course of this work. Any compensation or expenditure towards medical treatment of such worker shall be the sole responsibility of the contractor. The contractor is solely responsible for any damage or injury or accident that may occur to any of his personnel working under his contract. No claim whatsoever shall be entertained by ISI Delhi Centre in this respect.
- 13. After finishing of work Malaba shall be removed by the successful bidder at his own cost.
