The EMD amount will be adjusted in case of successful bidder and will be returned to the unsuccessful bidders.
5. The last date for submission of the sealed quotations is 2nd January, 2018 by 13:00 hrs. The **Sealed quotations** will be opened at 15:00 hrs on 2nd January, 2018 in presence of the interested bidders.
