
OFFICE MEMORANDUM

Subject: Implementation of 7th CPC for Faculty, Technical Officers, Chief Librarian etc. of the Institute.

A reference is invited to ISI's communication No.D.O./2017/580 dated 28th November, 2017 on the above subject. The matter has been examined in the light of instructions contained in the Department of Expenditure OM No. F.No.1/1/2016-E.III (A) dated 13th January, 2017 and in consultation with the Department of Expenditure. Accordingly, it has now been decided, with the approval of Competent Authority, to revise the pay scales in Indian Statistical Institute (ISI). in context of the general revision of pay scales allowed based on 7th CPC, as under:

- i. For employees of ISI whose pay scales are similar to those of equivalent categories of employees governed by UGC pay scales, recommendations of 7th CPC may be implemented in accordance with the instructions contained in Ministry of Human Resource and Development's (MHRD's) letter No. I-7/2015-U.II (1) dated 2nd November, 2017(copy enclosed).
- ii. For Professors, Associate Professors and Assistant Professors of ISI whose pay scales are similar to those of equivalent categories of employees governed by Indian Institute of Science (IISc) pay scales, recommendations of 7th CPC may be implemented in accordance with the instructions contained in MHRD's letter No F.No. 15-4/2017-TC, dated 27th October, 2017(copy enclosed).
- iii. The aforementioned communications of MHRD are applicable only to the extent of revising pay scales.
- iv. The above revision in pay scales is subject to the conditions that internally generated revenue of the ISI, as per its audited accounts, would be adjusted at the time of release of funds by this Ministry to the ISI from time to time.
