- G. It has been informed by the Ld. CPIO vide letter no. CAF/21-A/165/413-A dt. 02-01-2014 at point (4) that complete report/ statement of CVC in connection with the construction of mess building ISI Delhi Centre will be sent on the receipt of the report. Please supply copy of the document dt. 21-6-2012 from CVC regarding investigation of mess building at ISI Delhi Centre.  
If this information sought is not eligible for reply kindly supply/mention class of RTI Act under which it is not eligible/applicable.
- H. Please supply copy of letter dated 25-6-2012 addressed to Director CBRI by ISI Delhi Centre.  
If this information sought is not eligible for reply kindly supply/mention class of RTI Act under which it is not eligible/applicable.
- I. It has been informed by the Ld. CPIO vide letter no. CAF/21-A/164/599 dt. 02-01-2014 at point (18) that the structural design of mess building as per calculations and findings of committee headed by Sh. E. Somanathan is UNSAFE. Kindly provide the copy of document on the basis of which the Ld. CPIO has provided the given information.  
If this information sought is not eligible for reply kindly supply/mention class of RTI Act under which it is not eligible/applicable.
- J. It has been informed by the Ld. CPIO vide letter no. CAF/21-A/180/691(A) dt. 20-01-2014 at point (6) that "The work was suspended on 5-9-2011" against the information sought "Was the work being executed between 1.4.11 to 27.4.11 or was it stopped". The Ld. CPIO is requested specifically to inform about the status of work


in the mentioned period only i.e. 1.4.11 to 27.4.11. Kindly provide the copy of document in support of information provided.
