on 12.04.2013 to Additional Secretary and Financial Advisor, Head, Integrated Finance Division, MOSPI, Also Government nominated member in Council of Indian Statistical Institute Kolkata.

Dr B.Roy, Director, ISI vide Dated 29.04.2013 to hide the financial irregularities of Head ISI, DC in retaliatory move dismissed without taking CVC first stage and second stage advise.

Dr T.C.A.Anant, Secretary and Administrative Head to hide the financial irregularities of Head, ISI, DC set aside the advise of CVC forwarded vide No. 012.EDN.065 Dated 19.11.2014 and 012.EDN.065 Dated 30.06.2015 along with DARPG.P.2015.01387 Dt 10.03.2015 forwarded my complaint Dated 6.02.2015 against Dr B.Roy, Director, DA, ISI Kolkata to Honble Secretary, DPG, Cabinet Secretaries.

Also I on 30.01.2015 submitted my representation to Honble Sh Rajiv, Chief Vigilance Commissioner and Sh B,S,Bassi , Honble Commissioner of Police against Head, Indian Statistical Institute, Delhi Centre copies attached

Now false FIR 238 registered by Prof T.C.A.Anant, Secretary and administrative Head, MOSPI is transfer to CVC Moreover from the investigation conducted by IO , SHO reported in his report that no incriminating evidence of criminal liability against alleged persons came on record copy already submitted to DPG.

Now since false FIR transfer to CVC, MOSPI till date not released my legitimate dues even direction given by CS, DOPTAVD1A and CVC. therefore I request Honble Secretary, DPG and in charge VCC & DPG kindly provide me now SENIOR CITIZEN copy of action taken with regard to released of WHISTLE BLOWER legitimate dues from March 2012 and Pension and Pensioner benefits from August 2015.
