

With reference to your appeal referred to above, I am to state as follows :-


That the reply sent by the CPIO vide his letter No.CAF/21-A/102/2012-13/865 dated 12/14 April, 2013 to your application dated 23.2.2013 seeking some information, it was proper and apt in view of the fact that a complaint was lodged on behalf of the Institute before the concerned Police Station for initiation of a specific case over the complaint. As such it was contemplated that an investigation process would be initiated at the instance of the complaint by the Police authority. Hence, no information was furnished as, such disclosures might have impeached the investigation process. Thus, the protection of Section 8(1) (h) of the RTI Act 2005 was adopted rightfully by the CPIO.

Now, on subsequent enquiry it has come to our knowledge that no specific case has yet been started by the Police over the complaint, the undersigned being the Appellate Authority is pleased to furnish the point wise information as follows :-




